 Mayor Simpson updated the Council on the electrical upgrades that the Thayne Senior Center has asked for. The cost to increase the service to 300A would be \$2,000.00 and the upgraded dishwasher would be roughly \$1,986.31. The Senior Center is asking the Town of Thayne to cover the cost to increase the service to the building.

 Mayor Simpson stated that the Town has gotten the engineering agreement from Sunrise Engineering for the Pathway Lighting Project and asked for permission to sign the agreement and get started on the project.

- Mayor Simpson informed the Town Council that the Town of Thayne Sewer CD at the Bank of Star Valley is renewing for a term of six months at an interest rate of .6% with a total of \$141,790.25. Simpson suggested that the Town pull that CD and transfer those funds into the town general account.
- Councilman Woolley and Councilman Heward both stated that they would like to pull those funds out of the current CD and transfer them into the town's WyoStar II account.

Motion to pull Sewer CD at the Bank of Star Valley and transfer those funds into the Town of Thayne WyoStar II account.

Motion- Councilman Heward Seconded- Councilman Wicks Motion Carried

- Mayor Simpson stated that he has had Cliff clear out some of the built up snow at the Thayne Community Center so that the survey can be completed for the parking lot project.
- Councilman Heward started a discussion on a lawnmower purchase. Heward is currently looking at Star Valley Ski Doo and Thayne True Value and stated that he would like to keep the purchase local. Heward will send out an email to the Town Council with the brands and bids.
- Mayor Simpson informed the Town Council that there has been for sale signs put up on the available lots at the old cheese factory. Lot #1 on the north side is .81 acres and is \$200,000 and Lot #3 on the south side is .95 acres and \$215,000.
- Mayor Simpson mentioned to the Town Council in order to save time a list of all bills for April has been prepared and sent out. That complete list will be signed and approved rather than each bill for this month.
