### **Mayor Lainhart opened the public meeting regarding the Thayne Wright and Wan Noy Sidewalk Project at 5:30pm**

- The purpose of this public meeting is to receive any comments related to the proposed sidewalk project
- The project scope is to construct a 5' concrete sidewalk on the South side of Wright St between Main St. and Van Noy Parkway and to construct a 5' sidewalk on the East side of Van Noy Parkway from Wright St. to Osmond St. The sidewalk will connect with the existing sidewalk in front of the Thayne Community Center.
- The Town of Thayne received no written comments and no verbal comments were given from the audience.

#### **Debbie Merica**

- Debbie Merica started a discussion with the Town Council regarding Franklin Street, formerly known as King Street.
- Debbie stated that there had been issues with Franklin Street since 2006. Former Mayor Aullman and Town Council required the Merica and Stoker families to pave Franklin Street once lots began to sale in their subdivisions. Recently the Merica family had interest in lots to be used for family housing, but the potential buyer walked away from the sale do to the unfinished road and the spring at the corner of Franklin and Wright Streets. Debbie stated that this is a great area for future family development but cannot go further until there is a solution for the Wright Street spring.
- Mayor Lainhart suggested installing a cul-de-sac instead of having a through street to Wright Street. Debbie felt as though a cul-de-sac would not solve the issue; the spring is in the Town road right of way and needs to be addressed.
- The Town Council agreed that a Work Shop meeting shall be scheduled with all principal land owners to discuss a solution for Franklin and Wright Streets.
